Dear Board President Bobbitt:

Pursuant to §149.43 of the Ohio Revised Code, I hereby request copies of any and all documents having to do with the selection by the Board of Education of the Hilliard City School District of parcels for the site of future school buildings, including 120-000075-00, Franklin County, Ohio, (the "Property").

These documents should include, but not be limited to, the following:

* Copies of any and all official minutes from any and all Board meetings, committee meetings, subcommittee meetings and any other similar official gathering(s) of Board members where the selection of the Property was discussed.

* Copies of any and all documents that reflect what criteria were used to select the Property.

* Copies of any and all documents that reflect what criteria were used to reject other properties, including parcels 200-000035, 200-000080, 200-000444, 200-000001, 200-000002, 200-000019, 200-000060 (collectively, "the Anderson Farm"), and parcel 200-000117 (the "Sugar Property").

* Copies of any and all correspondence and documents -- including e-mails -- from Board member to Board member relating to the consideration of and selection of the Property.

* Copies of any and all correspondence and documents -- including e-mails-- between any and all Hilliard City School Board members and any and all representatives of the following organizations: the steering committee of the campaign supporting the school levy issues which will appear on the May 2, 2006 ballot (the "Committee"); the Big Darby Accord; Brown Township; Norwich Township; Washington Township; Franklin County; the City of Columbus; the City of Hilliard, Homewood Corporation and its affiliates, Planned Development Company of Ohio and its affiliates.

* Copies of any and all written recommendations and any other documents generated by the Committee, or commissioned by the Committee, with regard to the selection of the Property.

* Copies of any and all correspondence and documents -- including e-mails -- between any and all Hilliard City School Board members and the following individuals: David Lundregan, Bobbie Mueller, Mayor Don Schonhardt, Clyde R. (Butch) Seidle, David Meeks, Dale McVey, Tim Hamilton, Cheryl Roberto, Dan O'Brien, John Bain.

* Copies of any and all documents relating to the selection of members of the Committee. These documents should include, but not necessarily be limited to, the following:

* Any and all documents that reflect what criteria were used to select the members of the Committee.

* Any and all documents that reflect who had the authority to select members of the Committee.
